MINISTERS' MESSAGE

"For surely I know the plans I have for you," says God, "plans for your well-being and not for harm, to give you a future with hope" - Jeremiah 29:11

It is often said that the only thing certain about change is change itself. Our lives, world and even the Church are always changing, inviting us to new ways of thinking, being and doing as we continue the journey of faith. Throughout this journey we know that God is with us, leading us into the future with promise and hope.

The past year has been one of change and transition for us as a parish. In May we were saddened to say goodbye to Suzanna after five years of wonderful ministry with us. There was much to celebrate about the gifts she and Peggy had shared so generously in our parish, and a special farewell service and lunch were held to mark this ending. With Suzanna's departure a Ministry Profile (formerly known as JNAC) committee was formed to begin the work of assessing our ministry needs and searching for a new minister. Our initial hope was to find someone able to fill a "gap position" for several months, but after no applications were received a decision was made to follow the longer Ministry Profile process and search for someone to fill a long-term ministry position instead.

Another area of exploring change for us as a parish has been the ongoing conversations about our mission and vision, especially how they relate to our church buildings. Our Property Discernment Interest Group has been hard at work over the past year helping to facilitate this process. With the assistance of Edge, a network for ministry development in the United Church it has completed an IMNA survey and Viability report, hosted a community round table, met with a variety of individual groups, visited other church communities undergoing change and researched options for our buildings. In all these conversations we continue to ask what God's vision is for us as a community of faith and where God is calling us. Seeking to be open to the Spirit we await the exciting things God has in store for us!

As well as these changes within our parish, the wider United Church is also undergoing change. In early July the outcome of a vote taken throughout the Church showed a majority in favour of reducing the current four levels of decision-making in our denomination to three. While the impact of this restructuring process won't be felt deeply at the congregational level, it is another indicator of the broad changes happening within the Church.

With all of these changes happening around us, we are grateful for the things that have provided a sense of continuity and stability within our parish over the past year. Our Leadership Team continues to offer strong guidance and direction to the life and work of our congregations. Our House Groups, Interest Groups and UCWs all continue to participate in various ways in mission and ministry. Through the dedication of our Sunday School teachers we are seeing some growth in the Sunday School at St. Paul's and continued enthusiasm at Zion-Calvin's. Opportunities for learning and growth have come through various study groups, and the invitation to give generously from our hearts has been extended through the "We Sing Thanksgiving" Stewardship Giving program. As a community of faith we have shared fun times together as well as times of sadness and grief, as we mourned the loss of those who died over the past year.

In closing, I wish to express my thanks to all of you for the time, energy, commitment and prayers you have given our parish over the past year. Whether it be large or small, each of your gifts makes a

difference to the life and work of our congregations. I look forward to continuing to serve in ministry with you and to follow God's call into the future, trusting in God's goodness, grace and blessings.

PEMBINA PARISH LEADERSHIP TEAM

The role of the Leadership Team is to oversee the life and work of the Pembina Parish in accordance with The Manual of the United Church of Canada as written in The Constitution of Pembina Parish (5.1.). The Constitution states that the ministries are expressed through the faith-guided efforts of Committees, Interest Groups, and House Groups who are accountable to the Leadership Team. Members of the Leadership Team are active in many of the Committees and Interest Groups and / or are available as a liaison to these groups as needed. As we read the annual reports from these committees and groups, we can once again, reflect on what can be accomplished when we work together in fellowship sharing our time, talent, and skills as we strive toward supporting our Mission which is: 'To be a living celebration of God, as the body of Christ, serving the community and the world.'

During the 2017 - 2018 term, our Leadership Team as a whole had 11 meetings, as well as some additional working group meetings for specified tasks. This report will highlight some of our activities this term.

With facilitation by Rev. Suzanna Bates, and Rev. Ken Thomas we completed the required review of the United Church of Canada Remits which are items brought forward from the 42nd General Council as follows:

Remit #1 – Three Council Model - Approved 100% March 16, 2017

Remit #3 – Office of Vocation - Approved 100 % April 5, 2017

Remit #6 – One Order of Ministry - Opposed 100% April 5, 2017

Remit #4 – Funding a New Model – Approved 100% June 7, 2017

The United Church of Canada has passed Remits #1, #2, #3, and #4, according to correspondence received July 2017.

In May we bid a fond farewell to Rev. Suzanna Bates and Peggy Twyman, thanking them for their service and wishing them well on their journey to their new home and new church family in British Columbia.

Throughout this time of transition from a parish team ministry to a parish currently served by one minister, we acknowledge with appreciation, the ongoing dedication and leadership of Rev. Cathie Waldie.

A Leadership Team representative is working with our member representatives to complete a Ministry Profile in preparation for the search for a second minister. Two Leadership Team Members are participants on the Property Discernment Interest Group. A copy of the Property Discernment Interest Group Report will be available with the Annual Report.

We enlisted the help of some of our members to develop an Inventory of Tasks at St. Paul's and at Zion Calvin, and identify who currently takes responsibility for their completion. This helped us to see where there is a need to find volunteers to fill in vacancies.

In June, we recruited volunteers to manage some of the work that Rev. Suzanna and Peggy had been doing. Shannon Holenski took on the role of Editor and Chief of the parish quarterly newsletter. June Steiner accepted the challenge of managing the parish website. Arlene Link, our Office Administrator agreed to develop the power points for our worship services at St. Paul's with support as needed. Jason Ungarian agreed to continue to operate the computer and projector for Sunday Worship. We are still looking for volunteers to operate the sound system on a rotating basis for Sunday Worship.

Over the summer we responded to Fred Mayor's request to find a process for St. Paul's property and grounds ongoing maintenance and management. With Fred's expertise and guidance, we revised the Property and Grounds Inventory of Tasks to a Property and Grounds Maintenance Checklist with dates for task completion. In the fall, Glenn Dyck stepped into role of Property and Grounds Management Coordinator at St. Paul's. Glenn's leadership in this task has allowed Fred Mayor to step back from these responsibilities, which he has carried for many years. A successful 'Fall Clean Up' event was held at St. Paul's with 30 volunteer 'Movers and Shakers' participating.

In August, Leadership Team representatives met with four of our Youth Representatives from St. Paul's for ice cream and a chat about what they liked about their church and what their interests were and how they would like to be involved. These individuals have expressed interest in a mid week Youth Group with activities like discussions on topics of interest, cooking, eating, and visiting together, a multigenerational games night, glow bowling, or crafts. These young people also asked us to remember to include them when we are looking for volunteers for some of our events. They want to be involved when their schedules permit. Plans are in place to meet with Youth representatives from Zion Calvin for their input.

In September, we welcomed Anne Bateman to the position of Choir Director for the St. Paul's Choir.

In January, 2018, we met with our Elders, Karen Ching, Doug Lone, and Joan Peters to ask them what they were seeing and hearing around and within the churches, about our churches, where they have seen excitement, joy, and good energy, where they have noticed or felt frustration or concerns, and what their vision was for Pembina Parish over the next few years.

The Leadership Team has recently accepted proposals for three new Interest Groups. We thank these individuals for their interest, and wish them well with their new initiatives:

United Church Women Evening Group – December 2017

Worship Interest Group – January 2018

S.A.F.E. Stay Active for Life – January 2018

I have concerns for how much longer this model can continue, as the addition of new members to house groups is very slim. This past year only 4 houses were able to have new members added to their lists and every house saw a reduction in members.

Finance Interest Group

The Finance Interest Group members are: Alex Fedorchuk, Hugh Lumgair, Wes Schroeder, Louise Gardiner and Rev. Cathie Waldie.

The focus of this Interest Group is to monitor and review the ongoing financial situation of the Parish. The group assists in the annual Stewardship Giving program, monitors the fundraising projects, the income/givings and expenses to ensure the sustainability of the Parish. We meet quarterly to review the balance sheet and comparative Income Statement. We prepare the annual budget for presentation and approval at the annual meeting.

Financial updates were provided for News and Notes and the Parish Newsletters as well as monthly Leadership Interest Group meetings.

For the year ending December 31, 2017:

From a financial perspective Pembina Parish finished the year with a large operating surplus (\$49,268) vs the operating deficit that was approved by the congregation (\$-12,709). This was made possible primarily due to having the 2nd Minister position vacant from June to the end of the year.

The total expenses required to do the work of the Parish were projected in the 2017 budget to be \$283,413, whereas we actually spent only \$215,909, a savings of \$67,504. The majority of this savings came from a reduction in Minister's salaries & benefits (\$49,560) as well the monies allocated

for minister recruitment not occurring in 2017 (\$7,500). A variety of savings in other areas contributed to the addition reduction in expenses (\$10,444).

On the income side congregational givings were less than was budgeted by \$8,901 (actual was \$232,743 vs a budget of \$241,644). However, compared to 2016, givings were up slightly by \$2,112 (\$232,73 vs. \$230,631). Other income from fund raising and other sources exceeded the budget projection by \$2,874.

The Parish also collects and remits on behalf of the congregations monies directed to M&S work. For 2017 a target of raising \$38,000.00 was set. The actual amount donated to M&S work for 2017 was \$35,710, a shortfall of \$2,290. Thank you to all that donated to the M&S fund.

In terms of the Financial Position of the Parish (or what's in the bank and what is owing) the Balance Sheet as at December 31, 2017 was quite strong. The current assets (cash and receivables) sat at \$85,858, whereas our liabilities (accounts payable and demand loans) were only \$13,123, leaving the Parish with \$72,735 of working capital. It should be noted that \$21,530 of the cash in the Operating Bank account is recorded on the Balance Sheet as monies designated as a Building Fund Reserve. The finance interest group recommends that the congregation consider transferring this money to a special bank account.

In addition to the general operating funds described above, the Parish's Opportunity Fund currently sits at \$96,316. Of the Opportunity Fund money, \$27,366 is categorized as 'available to spend', \$33,337 is designated for repairs and improvements to Zion-Calvin, with the balance of the Opportunity Fund (\$35,613.50) considered 'endowment' (only able to spend the interest, the principle remains as an ongoing endowment).

The income statement and the balance sheet amounts for the year ending December 31, 2017 will be subject to review and revision by the Parish's external accountants, BDO. We do not anticipate any significant changes from their review engagement.

For the 2018 Fiscal Year:

The Finance Interest Group recently met to prepare and submit a detailed budget for 2018 to the Leadership Team. The budgeting process included a thorough review of last year's expenses with increases, decreases and additions made as the Group felt were needed. The Finance Interest Group also received several budget requests from various Interest Groups doing work in the church and these were also included. The budget was built around the Parish not having a second Minister in place and on the payroll until July 2018 and has based the salary for that new position at .8 FTE. The total expenditures required to fulfill the work of the Parish in 2018 are projected to be \$249,837. Using an estimate that the congregation's givings will decrease by 3% over last year, the Parish's revenue is projected to be \$256,743. The net difference between our projected income and expenses is an estimated surplus for the year of \$6,906.

The Finance interest group also did some projections (using this year's income and expense budgets) taking into consideration what a full year of having both a full time and part time ministerial staff (1.8 FTE in total) would look like. Based on our calculations we estimate an annualized loss of \$32,000. This would indicate that the Parish will need to be proactive to ensure that we can generate additional income each year through some means (increase in givings – e.g. more per current member and/or more members, new fund raising, additional building rentals, and ??).

Based on the report tabled by the Building Discernment Committee it would appear that our Parish will need significant monies in the future to keep St. Paul's building in good repair. No allowance was made within the 2018 budget for increasing our building reserve (which currently sits at \$21,530). With guidance from the Discernment committee and the congregation, it is felt that this is something that should be considered.

The role of this Interest Group is to handle any bequests or memorial donations given to Pembina Parish and to manage the Opportunity Fund account. The group also receives and recommends applications for projects to be funded from the Available-to-be-Spent portion of the Opportunity Fund.

Three meetings of this Interest Group were held in 2017. Members were informed of two bequests given to our parish. The first was a bequest of \$23,000.00 from the estate of Gordon Cowan, designated for Zion-Calvin United Church. These funds were placed in the Opportunity Fund account and designated for Zion-Calvin through application. The second bequest was of \$10,000.00 from the estate of Gary Bartleman. These funds are divided equally between the Endowment and the Available to be Spend according to the terms of the Opportunity Fund. It is hoped that a service of recognition for Gary's bequest will be held in early 2018.

Three applications for disbursement from the Opportunity Fund were received in 2017 and approved by the Leadership Team:

There were three meetings of the Trustees held in 2017. Most of the meetings focused on the conservation and restoration project of the church building. Financial updates of the project costs and grant payments were provided at each meeting.

In February the Trustees decided that the following would be priorities for the 2016-2017 grant application from Manitoba Culture and Heritage:

Contact Steckley Consulting Engineers Inc. (for inspection of brackets and cable)

Repair the rotten wood on the northwest corner of the vestibule

Seed the black topsoil for site drainage

Install a cosmetic cover for the bolts and cable

Contact Steckley Consulting engineers Inc. design for the bell tower project

A new grant application for 2017-2018 was completed in March with the following priorities:

Completion of bell tower beams, strengthening the base, etc.

Painting of the bell tower

Painting of new wood repairs to the corner of the vestibule

Repair of the north chimney

In June the Trustees were informed that \$3,065.00 had been approved by the Provincial government's Designated Heritage Building Grant program to assist with the conservation project. An additional \$4,990.00 was approved in October.

In December the Trustees accepted a quote from Giesbrecht Cabinets (Justin Giesbrecht) for the bell tower stabilization project for materials and labour in the amount of \$6,949.50).

We are so grateful that there is now an active Worship Interest Group in place that can take this responsibility from our committee.
