Rev. Mel Kauppila welcomed folks and thanked them for making time and taking time to be present at the meeting to move forward in Pembina Parish' ministry needs and future.

Acknowledgment of the Land: As we gather in St. Paul's United Church we are aware that we gather on Treaty One Territory, traditional land of the Cree, Oji-Cree, Dakota, Anishinabe and homeland of the Métis Nation.

Opening Prayer: Rev. Mel led a time of prayer

#### **Enabling Motions:**

To name Rev. Mel Kauppila, Presbytery Representative as Chair CARRIED

Moved by Jean Motheral, Seconded by Myrna Mayor

To name Marlene Holewka as Recording Secretary CARRIED

#### Purpose of the meeting:

Chairperson, Rev. Mel Kauppila explained that the purpose of the meeting was to hear and act on the report and recommendations of the Ministry Profile Committee and stated that only confirmed members may vote. Further, Rev. Kauppila explained that if they wish adherents may be allowed to speak and participate in which case a motion should be offered that adherents be made corresponding members.

Moved by Hugh Lumgair, Seconded by Rick Britton

That corresponding privileges be extended to adherents. CARRIED

#### **Report of Ministry Profile Committee:**

Edith Lovatt provided a report on the work of the Ministry Profile Committee and the Ministry Position Description, highlighting that the individual could be an Ordained, Diaconal or a Lay Minister with a focus on engaging Youth and Young Families in the 40 year old and younger age group into the activities of the church. The position is Permanent Part time 4 days or 32 hours per week. The expectation is that this minister will dedicate 15% of time to Worship (1 service/sermon per month including Youth in the service), 20% to Pastoral Care, 10% to Leadership, 50% to Youth Faith Formation, and 5% to the Wider Church.

Edith and the Ministry Profile Committee led a time of discussion and questions for clarification. Discussion points included:

Affirmation that we are on the right track – getting someone to work with Youth and Young Families, when we consider the average age of our congregants, we need to attract young people. This position will provide support to our current minister to help to prevent burnout.

Years ago they could not get a Diaconal Minister to provide Christian Education but this can work quite well.

From a Finance perspective, it was noted that in spite of the fact that we have a surplus, we forecast a reduction of 3% in givings annually.

Questions asked for clarification included:

Would there be restrictions on what a Lay Minister could do?

Could the Lay person be someone like a retired teacher or social worker?

Response: The term as the Ministry Profile Committee understood it could be a Lay Minister (educated within the United Church of Canada), and that this would be amended on the position description.

Why was the position .8 (4 days a week)?

Response: Money – to reduce cost, but make it enough hours to be attractive. We will still need some Pulpit Supply.

Is there a moving allowance?

Response – Yes \$6000. and it has been included in next year's budget

If we hired somebody as a support person for youth, how many hours could this be?

Response – 14 hours / week of contract work

Can our budget sustain this?

Response – For a few years.

Is this a Call – Is there a set time frame?

Response – This is a Call without a designated time frame.

When posting this position are you limited to posting within the United Church?

Response – We need to follow the process of the United Church. Once posted on the Conference Web Site it can be seen by everyone.

- Salary up to Category F plus 5% COL 2
- Vacation as determined by the United Church Handbook
- A maximum of two weeks study leave within each pastoral year, including Sundays.
- Housing allowance in accordance to COL group 2
- Days off: three days per week, to be negotiated with the other team member.
- Four Sundays a year off to be determined with team members
- Continuing education allowance as per the year's schedule
- Travel allowance of \$0.41 / kilometer
- Adequate administrative assistance defined as 21 hours per week shared with other team members and the church schedule.
- All other terms will be in accordance with The Manual and United Church policies.
- Salary and benefits administered by the ADP payroll system WX08.
- Basic telephone expense of \$35.00/month (excluding personal long distance calls)

Dear Friends,

A few weeks ago the above verse was part of the lectionary reading for our Sunday morning worship services. As I reflected on this text for preaching, I thought of what a fitting description it was for our life at Pembina Parish over the past year. Just as Jesus spoke of the need for new ways of doing things that came with his life and ministry, so has our journey together led us to new ways of thinking and imagining our future together.

One of the "fresh wineskins" our parish has been exploring for some time is discerning where God is leading us with respect to the stewardship of our church buildings. Our Discernment Interest Group has done extensive work and consultation in looking at possibilities for St. Paul's as we move forward, and will present its recommendations at the annual meeting. So too has our Mission, Vision and Values Interest Group been hard at work over the past year, creating a draft list of our core values and a new Mission Statement for us to consider. As well as these important pieces of work, our parish decided to continue the search for additional ministry staff by creating a position for a Congregational Designated Minister with a focus on children, youth and families. Lastly, our Affirming Conversation Interest Group continued the process of moving as a parish towards becoming an Affirming Ministry of the United Church, and will be encouraging us in this endeavour. I am grateful for all those who have given so much of their time, energy and commitment to these important tasks.

In addition to these new things that are happening in our midst, the regular life of our parish continues: celebrating God's presence in weekly worship, nurturing our children and youth in Sunday School, growing in faith through Bible study, sharing in fellowship and social events together, and supporting the mission and outreach of our local and wider church. I am grateful for all those who help keep things running smoothly through the Interest Groups, House Groups and individuals who bring their unique gifts and skills to build up the life of our congregations.

One of the gifts of being part of a faith community is being able to support one another in times of joy and sorrow. This year we rejoiced with those who celebrated special events in their lives, and grieved with those in our church family and community who lost loved ones. We also journeyed with those facing stressful and difficult times. I am grateful to all those who provide pastoral care to those who are in need of support, as well as those who provide meaningful ministry at times of grief and loss: our choir, musicians, UCWs, and everyone who donates to or helps with funeral lunches.

In closing, I would like to especially thank the other members of our staff team with whom I am privileged to serve: Laurie our Office Administrator who we welcomed early last year, and Thong, our custodian at St. Paul's who keeps things neat and clean. I would also like to thank the members of our Leadership Team for their dedication and leadership over the past year. As we look to the future and the "fresh wineskins" we are being called to fill, may God continue to bless us with wisdom, guidance and hope in our journey.

#### PEMBINA PARISH LEADERSHIP TEAM

The Pembina Parish Leadership Team is responsible for overseeing the life and work of the parish in accordance with The Manual of the United Church of Canada, https://www.united-church.ca/sites/ default/files/the-manual 2019.pdf, and as described in The Constitution of Pembina Parish (5.1.). Our Constitution states that our ministries are expressed through the faith-guided efforts of Committees, Interest Groups, and House Groups who are accountable to the Leadership Team. Leadership Team members are also active in various Committees, Interest Groups, and House Groups. In addition each member of the team is assigned to act as a liaison to specific Interest Groups, with a goal to maintain open communication, and to respond to needs as they arise. Our meetings are open to anyone who wishes to attend. Minutes are available in the Administration Office and are posted on our website. https://www.pembinaparish.com/minutes-of-meetings.html Our meetings open with worship and reflection lead by Rev. Cathie Waldie. Reports are received from our Treasurer pertaining to Finance, our Ministry and Personnel (M&P) Representative pertaining to staffing matters, our Minister, and our Interest Group representatives upon request, or through their Leadership Team liaisons. Decisions are made as required based on these reports and requests, with expert input and consultation from other Interest Groups when needed. We meet with our Elders, and Youth Representatives at least once a year, and with the Trustees for matters pertaining to things like Insurance and Liability policies when required. This report will include a few highlights of our work this term. For more information, a Motion Archive containing a record of all motions made at our meetings over the past 14 months is available for your review in the Administration office.

Since our last Annual Meeting, we have had 11 business meetings. Starting in September, we met 9 additional times to work on the review of our **Mission** Statement, (our purpose) using what we had heard our congregants say about **Values** (what matters to us) to guide us. Our process included consideration of our **Vision** (for our future growth and development). We were grateful to have Sue Nelson and Maureen Irvine join us for these lively discussions, and in November we welcomed Brian Saunderson to add his perspectives. These discussions continue as we share what we have drafted with you, and ask for the input of all people of the Parish. It is important that our Mission, Vision, and Values have meaning for everyone. They are there to help guide our behaviour inside and outside of our community of faith, and our activities and planning for today and for the future.

The Leadership Team is updated regularly on the progress of the Property Discernment Interest Group, in particular the Capital Planning Group, and the Rightsizing Group. This work currently pertains to St. Paul's building but is important to the entire Parish. Recent information sessions have been offered by Earl Gardiner and Bruce Shewfelt before church services in January and February, with opportunities for you to ask questions. A full report from this group is available as part of this Annual Report. Please read and discuss this report, and prayerfully consider the options presented, and then join us at the Annual Meeting for further discussion on next steps.

Our designated Ministry Profile Committee, led by Edith Lovatt, has kept us informed on their process of searching for an Ordained Part Time Ministerial Position, with a focus on engaging young adults, youth and children. This part time position was advertised from February – August, 2018. During the summer, having received no applicants, the committee asked the Leadership Team for guidance on how to proceed. We knew we had to consider another option. We used our United Church of Canada Manual as a resource to learn about the Congregational Designated Minister (CDM) position, and then had some discussion with representatives from a United Church in our area who had experience with this option. Representatives from the Ministerial Profile Committee agreed to refine a job description for this new CDM position, and it was approved by the Presbytery Pastoral

Relations Committee in November, 2018. Together, we developed a job posting, and the advertising began February 1, 2019.

In November, Leslie Bezte accepted the challenge to lead a new "Young Families, Young Persons "Interest Group with an aim to learn more about the needs of this group and to start by engaging our young families in occasional fun and fellowship events. Leslie is currently serving on the Leadership Team, the Property Discernment, Rightsizing Group, and is a St. Paul's Sunday School Teacher. The first event was a Games Night for all ages, at St. Paul's, in November, and all who came to play, visit, and snack had a great evening.

This past year the Leadership Team, on consultation with other involved groups has: Reviewed / revised four policies:

- Duty of Care Policy for Vulnerable People April 2018
- Funeral / Memorial Policy and Information June 2018
- Use of Space Agreement October 2018
- Information and Policy for Weddings Approval pending

Developed one new policy:

- Accessible Customer Service Policy - November 2018

We are in the process of drafting proposed changes to the Constitution of the Pembina Parish, Approved September 8, 2013, and Amended, February 26, 2017. The purpose of the proposed changes is to clarify some of the points and to reflect some of the changes in the United Church of Canada effective January 2019.

Pembina Parish is enriched by everyone at both St. Paul's and Zion Calvin who share their time and skills by participating in many organized Committees, Interest Groups, and House Groups. In addition, many help out whenever there is a need, for example caring for one another by supporting funerals, or providing refreshments and then cleaning up, or helping to care for our buildings and grounds. This is often done quietly behind the scenes. Each one of you is very important to the ongoing life of our Parish as we live our Mission. Your efforts are noticed, appreciated, and truly make a difference! Your contributions remind me of the inspiring words of a dynamic hymn by *Steve* Angrisano and Tom Tomaszek, that we enjoy singing together.

## **Finance Interest Group**

The Finance Interest Group members are: Alex Fedorchuk, Hugh Lumgair, Wes Schroeder, Louise Gardiner and Rev. Cathie Waldie. The focus of this Interest Group is to monitor and review the ongoing financial situation of the Parish. The group assists in the annual Stewardship Giving program, monitors the fundraising projects, the income/givings and expenses to ensure the sustainability of the Parish. We meet quarterly to review the balance sheet and comparative Income Statement. We prepare the annual budget for presentation to the Leadership Team and approval at the annual meeting. Financial updates were provided for News and Notes and the Parish Newsletters as well as reported monthly at the Leadership Interest Group meetings.

The Financial Interest Group also spent considerable time this year developing appropriate policies, procedures and systems to support the effective and safe management of the Parish's financial processes. This included an internal auditing procedure that is carried out by the Interest Group twice per year.

## Parish Operations - For the year ending December 31, 2018:

From a financial perspective Pembina Parish finished the year with another large operating surplus of \$56,360. The budget approved at the beginning of the year projected the Parish having a \$6,906 surplus. This excess was again created due to having the 2<sup>nd</sup> Minister position vacant for the whole year, whereas we had budgeted the new minister to start in July 2018 (half the year). It was encouraging to see that the congregational givings were very close to budget (actual = \$223,208 vs budget of \$226,013). In October we were quite concerned, as at that point in the year we were showing a shortfall of over \$22,600. However, in November and December the offerings increased significantly, exceeding what was anticipated in those two months. We contribute this increase to an effective Stewardship Program. Looking at the trend in givings, compared to 2017, where our congregational offerings were \$232,743, we did experience a 4% decrease, year over year. Our sincere thanks and appreciation to all the volunteers in the Parish that worked on fund raising events (such as the Fall Supper, Mother's Day lunch, Darlingford Craft Sale, Choir Concert, Co-op gift cards, Sunday School plant sale, etc.) as our fund raising for the year netted \$16,367 and exceeded the budget by \$3,267.

#### Flow Through Revenue:

The Parish collects and remits M&S donations on behalf of the Parish that are designated to the United Church's national M&S fund. The target set at the annual meeting for our Parish was \$38,000. As the statement below indicates, the total raised and remitted for 2018 from the Pembina Parish was \$34,720.

There are a very dedicated group of volunteers in the Parish that regularly put on Soup & Pie fund raisers and they then in turn donate this money to local outreach projects. Our thanks for the important outreach this group does on behalf of the Parish.

#### **Restricted Funds:**

The Pembina Parish has 4 separate restricted funds that have been established, two that are specific to the two church buildings and the other two related to what we call opportunity funds. Any donations received that are designated specifically to any of these funds are recorded and tracked separately. The statement below reflects the income that came in during 2018 as well as any approved expenditures from the funds. Note that the Opportunity Fund – Endowment has been established as a legacy fund and only the interest from this account can be used for projects.

#### **Balance Sheet:**

In terms of the current financial position of the Parish the Balance Sheet as at December 31, 2018 was quite strong. The current asset balance (cash and receivables) was \$111,525. Whereas our liabilities (accounts payable) were only \$1,911, leaving the Parish with \$109,416 of retained earnings. A portion of this surplus is invested in a Platinum Savings account (\$50,000) at the Access Credit Union, with the balance in the operating checking account. The Restricted Funds detailed above (\$153,551) are fully funded and invested in combination of Platinum Savings and GICs at the Access Credit Union.

The income statement and the balance sheet amounts for the year ending December 31, 2018 will be subject to review by the Parish's external accountants. We do not anticipate any changes as a result of their 'Notice To Reader' engagement.

#### **Budget for the 2019 Fiscal Year:**

The Finance Interest Group recently met to prepare and submit a detailed budget for 2019 to the Leadership Team. The budgeting process included a thorough review of last year's expenses with increases, decreases and additions made as the Group felt were needed. The Finance Interest Group also received several budget requests from various Interest Groups doing work in the church and these were also included. The budget was developed on the understanding that the new Congregational Designated Minister would be hired and working by May 1, 2019 and that this position is .8 FTE. The total expenditures required to fulfill the work of the Parish in 2019 are projected to be \$252,417.

It was challenging to determine what estimate to include for congregational offerings in this year. Based on the 4% drop in donations that occurred between 2017 and 2018 it might suggest that we should decrease the expectation for 2019 by 4%. However, the Finance Committee has a sense that there is momentum and renewal building within the Parish and thus we are recommending that for 2019 budget be based on the 2018 givings less 0.5%. With this confidence, and making the assumption that the new minister won't start before May, we are able to project, and recommend, a budget for 2019 that shows a small surplus of \$843.

#### AFFIRMING CONVERSATION



This Interest Group was formed in September 2016 to explore what it might mean for our parish to become an Affirming Ministry within the United Church of Canada. Our Leadership Team had given its unanimous approval to move forward with this exploration. The designation "Affirming Ministry" is given to communities of faith that have intentionally reflected on what it means to be inclusive and welcoming of people of all sexual orientations and gender identities. The process of becoming an Affirming Ministry takes time and includes many opportunities of learning, conversation, dialogue and reflection.

Several events were held by this Interest Group in 2018:

- A meeting in late June to discuss the steps our parish had already taken in the Affirming Ministry process, and to look at ways in which we might move forward.
- A Bible study in September on "Transcendent Love" written by Rev. Patrick Woodbeck exploring several stories from Scripture about God's all-inclusive love.
- A Sunday in October featuring guest preacher Rev. Patrick Woodbeck in worship, followed by a workshop led by Patrick outlining the steps in becoming an Affirming Ministry, as well as explaining the terminology of LGBTQTT2S\*. Patrick also responded to some questions from visitors of the wider community who were there and challenged his presentation.
- A follow-up meeting in late fall to look at steps in moving forward. At that meeting Maureen Irvine and Deb Hamilton agreed to take on the role of co-ordinators of the Interest Group.

In the coming year this Interest Group hopes to connect with a United Church congregation in the area who is an Affirming Ministry, work on a Mission Statement and have another guest speaker in worship. New members are welcome to join us in this journey!

### **Ivy League Story**

In 1996 a group of women from Pembina Parish decided that they needed to get to know one another better and grow in our faith, away from the busy lives we led.

The first retreat was held at Camp Koinonia on Adam Lake just south of Boissevain. Karen Ridd facilitated the weekend, she helped us to see the walls (the bricks) that prevent us from being God's hands in our world. We wrote words (on the bricks) that prevent us from being the real people that God intended us to be. These bricks formed a wall. Karen led us to realize that something as small and ordinary as an ivy vine has the persistence and power to crumble a brick wall and that like Ivy we should not let anything hold us back from living our faith more completely and wholly.

We found after that first retreat that we really wanted to spend time together, just being ourselves, laughing and having fun. Thus the Ivy League was formed -- not an elite school group-- but a group of women breaking down walls. A group of women supporting one another, laughing and EATING!

23 years later we are still a group of women who get together once a month, sometimes just a few of us, other times a dozen or even 2 dozen, but still a closeness that happens with just getting together to eat and share. Many women have joined us as newcomers to the church community, just wanting to make connection, some of the group do not come to church but are looking for connections with other interesting ladies.

We have gathered at many different venues for our meals, local restaurants, local homes and the church, the places we can find food are endless!!

So ladies, do come and join us, we are still a group of ladies breaking down walls!!!!

#### Pembina Parish Property Discernment Interest Group Report

This document provides **Questions and Answers to Discernment Committee recommendations** pertaining to the St. Pauls facility. Our recommendations will be presented on March 10<sup>th</sup>, 2019 at the Parish Annual meeting. *Please consider this your invitation to join this important conversation*.

#### WHAT HAS OUR COMMITTEE FOUND?

- After consulting user groups and the congregation, we have determined the Right Size footprint for the St Pauls congregation is about 9000 square feet; a 30% reduction from our current size.
- A Multi Purpose Sanctuary allows St. Pauls to achieve a Right Size footprint and was considered an acceptable "option" by 88% of St. Pauls congregants surveyed.
- Draft architectural sketches have been developed to illustrate how a redesign could work; including Multi Purpose Sanctuary, relocated kitchen, renovated meeting space, offices and new space for the Sunday School (see sketches page 2).
- A Multi Purpose Sanctuary can still seat 180+ within the sanctuary and 125 in the Narthax for overflow (see sketches page 2). Our current space holds 300 + overflow in the Narthax.
- Right Sizing allows us to either lease the CEU or remove it and replace it with new parking.
- St Paul's building foundation is in good condition, but repairs will be required to roofing and
  mechanical systems soon. A Right Size footprint will need renovations/repairs to roofing/ siding,
  upgrades to windows and flooring, and re-painting; to extend the life of the St. Pauls building.

#### WHY SHOULD WE CONSIDER THIS RIGHT SIZE OPTION?

- . We can reduce operation, repair and maintenance costs by reducing our footprint 30%.
- We can recoup costs that would otherwise be required (e.g. \$100,000 is required almost immediately to repair the CEU roof). Two options are being proposed:
  - Remove the CEU, replace with parking and sell part of the existing parking lot; OR
  - Keep the CEU, demise (separate) it from our Church and offer it to developers for 10 to 20-year lease (including shared operation and maintenance costs).
- Our building needs significant renovations (e.g. estimated at \$500,000).
- New construction is expensive; in the order of 2 3 times renovation costs (e.g. \$1,500,000).

#### WHAT DIRECTION IS THE COMMITTEE REQUESTING AT THE PEMBINA PARISH ANNUAL MEETING (MARCH 10TH)?

- Approval to invite outside proposals for leasing (10-year min) the demised (separate) CEU.
- Approval to proceed with architectural/engineering drawings for Right Size building options.
- Approval to proceed to detailed construction cost estimates and scheduling for both options (e.g. lease or remove CEU).
- Establish a building committee, responsible for planning, financing and reporting to Leadership.
   Bring detailed plans, costs and scheduling for final Parish approval (e.g. spring or fall, 2019).

#### HOW CAN I LEARN MORE?

- The committee will host open house Feb 3<sup>rd</sup> and Feb 10<sup>th</sup> at St Pauls.
- The committee is preparing a detailed report of all our findings.



#### **SUMMARY AND SKETCHES**



#### REFUGEE SUPPORT GROUP

As of Feb 4<sup>th</sup>, the first family from Syrian, the Daouds, have been in Morden 3 years. Everyone is continuing to learn English and speak it with confidence. On April 26<sup>th</sup>, 2018 Halima was able to greet her brother Idrees Shahab and his family at the Winnipeg airport as they arrived in Canada on the 100% government sponsored program. The Daouds then opened up there home to the relatives and they all lived together for 6 weeks. During that time the support groups got together and found the Shahab's a house and all the furnishings. We are not financially supporting the Shahab's yet members of the group have chosen to be social and language support to them. It has been shown that refugees who have support from a local group have an easier time integrating.

Everyone is settling into a routine of education, the adults all attend English classes through the Regional Connections Language program; all the children are in school from kindergarten up to grade 11. The children all had good report cards and with some homework support from committee members are able to progress at grade level in school.

We continue to await the arrival of the two Daoud boys who are in Germany just waiting for their travel visa's to be approved thru an office in Vienna.

Both families are very appreciative of all the support they receive from the 3 churches. Thanks to everyone who has helped out.

#### ST. PAUL'S TRUSTEES ANNUAL REPORT

# **Duties of the Trustees include oversight of building & property.**

Two items were reviewed and recommended to the Leadership Team for action.

These included the Duty of Care Policy for Vulnerable People

2. And the Church Abuse Liability Insurance.

A request was made from Michael Pahl, pastor of Morden Mennonite Church, chairperson of our Refugee/Newcomer Support Committee regarding liability insurance for volunteers working with refugee families and in addition requiring a Criminal Record check and Child Abuse registry check.

"A copy of the church's Certificate of Insurance, confirming not less than \$2,000,000 Commercial general Liability coverage including Non-Owned Automobile Liability, \$2,000,000 Directors and Officers Liability coverage, \$2,000,000 Occurrence for Abuse Liability coverage, with MCC added to the policy as Additional Insured."

The Church Abuse Liability Insurance was added to our current policy at a cost of \$400 (yearly). The Criminal Record check and Abuse Registry check have been added to the policy on Vulnerable People, including refugee families.

The trustees were polled concerning the necessary repairs required (roof repairs, concrete work at church entrance and Narthex skylight) and responded.

In addition, a review of the "rental policy & agreement" for the use of space in the church was sent to the trustees for review and comment.

#### ZION-CALVIN UNITED CHURCH BOARD OF TRUSTEES

Progress on the Zion-Calvin church building restoration program went well through 2018. Considerable consultation with Steckley Consulting Engineers Inc. was undertaken for the design and placement of beams to give support to the bell tower. Bearing walls were designed that tied into the building's foundation system and the newly installed roof support cable.

Justin Giesbrecht of Giesbrecht Construction built the bearing walls. In consultation with Gordon Menzies from Manitoba Historic Sites Branch Justin stained and installed finishing materials that match the original interior of the church. The work was superbly done.

In the spring, the lower portions of the north- and west-facing exterior walls of the front entrance were dismantled and replaced with new insulation and siding. Below-grade materials were thoroughly protected with wood preservative, blue-sheet membrane and a galvanized iron flashing. This work was completed by volunteers.

On June 14<sup>th</sup>, Darlingford experienced a destructive hail storm. The recently-shingled church roof sustained heavy damage as did the eavestroughs, downspouts and several windows. The insurance payment was long in coming and very short of the damage estimates. Due to the lateness of the season by the time the damage assessment and cost estimates arrived, the roof re-shingling and other repairs including windows will be completed in 2019. In the meantime, the damaged windows have been insulated and boarded up.

Trustees are in the process of working with BSI Morden to review our building insurance. We are cautiously making plans to paint the exterior of the church building.

It was with regret that the Board of Trustees last summer received notice of resignation from Betty Hamilton. We are grateful for the considerable time and energy she has contributed to this group.

We are still standing.

This committee's terms of office are two years with an optional third year. This year we say good bye to Earl as he has completed his third year. We are very grateful all he has done and appreciate his expertise leading this committee.

#### AGASSIZ PRESBYTERY REPORT

The decision had been made in 2017 to change the church governance system from a 4 court model to a 3 council one thus eliminating Presbytery. Most of the discussion this year was about how to go about that by January 2019.

Most of our table discussions this year were around ways of staying connected when we no longer have Presbytery meetings to draw us together. A transition list was sent out to presbyteries to give us some steps to consider in wrapping up our business. Some of the questions we needed to ask ourselves were: What do we do with our remaining finances? Support for Rock Lake/ other United Church camps? What is important that doesn't fit into the new structure? What do we need to give up on? How do we show staff and volunteer appreciation? Are there special plans for the final meeting? Are there relationships beyond the United Church that we need to carry forward? Is there a role for a network or cluster within the new system? So many questions ...

A recent update from Sherri McConnell (chair of Region 5 Commission) is as follows: "The Region 5 Commission is already hard at work putting together a working structure so that the mission and ministry of our region can continue and flourish in this new time"....

"The Region 5 Annual Meeting will be an important time, as this is when the work and ideas of the Region 5 Commission will be presented, and our region will have the opportunity to vote on how we want to organized and structure our work as a region, and how we want to live out our mission and ministry in new ways – through clusters, networks and other ways not yet imagined.".The Region 5 Commission plans to meet for a face-to-face meeting in February to discuss ideas for the regional structure further, and to imagine ways the mission, ministry and justice work of our region can continue to happen."

So the ministry and lay persons of Agassiz Presbytery are fondly remembering the past (some have spent many years as members) but looking to the future – not completely gone – just redesigned.
