8.1 Minister's Report

Rev Carrie is observing energy for learning and growth in the interest shown for book study and Indigenous issues; she is talking with local churches about shared activities; feedback has been very positive on affirming and on the young adult service June 20th; social tension is evident in the community between those getting vaccinated and those not; summer worship services will be lighter/playful, some outdoors; the Covenanting Service is June 27th.

8.2 Ministry and Personnel Report

Karen reported on vacation dates for Rev Carrie and Laurie, and on actions to be taken re policies on workplace harassment-prevention and sexual misconduct prevention; **Action:** add review of these policies and their affirming language to the next agenda; discussion about an "office cell phone" and the need for a phone at Zion-Calvin; **Action:** Karen will ask Laurie Wiebe to make recommendations and provide details of phone plans; no conclusions were reached about improving contact with congregants who lack internet access; there was consensus that Rev Carrie respond positively to a request for her to marry a Muslim couple.

8.3 Zion-Calvin

Kathryn reported that maintenance is ongoing with the removal of a downed tree, annual water analysis completed and arrangements for the installation of internet cable; would like to have new signage for the Affirming celebration; **Action:** add church signage to the next agenda.

8.4 Finance Report

Nancy referenced the distributed Statement of Income and Expenses for the Period Ending May 31, 2021; next meeting she will bring a comparable for June 2020/2021.

8.5.1 St. Paul's Building Group

Brian reported that anticipated project costs have risen; a congregational meeting is planned for July 8, 2021 at 7:00 pm online at which time an update will be provided to congregants and a motion will be presented seeking approval for an increased budget.

8.5.2 Opportunity Fund

Nancy presented the minutes of the Opportunity Fund Interest Group meeting of June 22, 2021 to support their recommendation for approval of an application request from the St. Paul's Building Discernment Group.
